6911	<p>Chairman’s announcements Cllr Goodman welcomed everybody to the meeting.</p> <p>A presentation was made by two Borough Councillors through their Ward Initiative Funding to local organisations:</p> <ul style="list-style-type: none"> • Cllr Dearing presented cheques to Mr Dennis Ainge, Chairman of the Desborough Pocket Park Volunteer Group and Mr Mick Ward, Treasurer of the Town Centre Partnership. • Cllr Derbyshire presented a cheque to Mr Mick Ward, Chairman of Marlow House. These can be used to record any events happening in Desborough.</p>
6912	<p>Apologies for absence Apologies for absence were received from Cllr M Tebbutt and Cllr G Dixon. It was <u>RESOLVED</u> to approve the apologies for absence received.</p>
6913	<p>Declarations of Interest by Councillors Cllr Soans would not take part in any consideration of planning matters as he is on the Planning Committee at the Borough Council. Cllr Coe declared an interest in Planning</p>

<p>6914</p>	<p>Police Report PCSO Breeze went through the crime figures for December 2010 and January 2011 to date. Concern was raised that the Christmas lights at Icicle Star were vandalised the week leading up to Christmas.</p>
<p>6915</p>	<p>Update on Sainsbury's revised planning application Mr Keys, Consultant, presented to the Town Council:</p> <ul style="list-style-type: none"> • The reasons why Sainsbury's has resubmitted a planning application for a supermarket situated on Magnetic Park, Desborough. • Sainsbury's strong track record of working with towns to provide funding and specialist people to support the development of the town centre. • That it is accepted that there is a need for a food store in Desborough and that it is not unusual to have a store in the town and another on the edge of town. • There are two key problems with the Lawrence Factory Site, firstly the covenant which is still in place and also that the site does not work commercially. <p>Mr Keys highlighted that Hampton Brook, the Developers of Magnetic Park, have tabled a considered scheme for the Lawrence Factory Site as a non-food mixed use development. He asked the Town Council to consider Sainsbury's commitment to the Town and their commercial agreement with Hampton Brook in respect of the development of the Lawrence Factory Site. He stated that these proposals are credible, deliverable and will provide what residents want.</p> <p>Councillors raised the following questions/issues:</p> <ul style="list-style-type: none"> • Cllr Durward asked if the Tesco Planning Application is approved would it affect Sainsbury's commitment to Magnetic Park. Mr Nicholson, Town Planner Sainsbury's, confirmed that the Company is committed to Desborough. • Cllr Hollinshead raised concern about the vehicular access to a store based on Magnetic Park in relation to the current traffic issues at Magnetic Park with lorries parking along the access road. Mr Nicholson confirmed that their planning application included a robust highways solution which will be tested. • Cllr Dearing asked for further details of how Sainsbury's support local businesses and marketing in the town. Mr Keys explained that Sainsbury's would look to work together with the retail community and that the local Store Manager and staff would be part of the Town Centre Scheme and would not act autonomously. Sainsbury's also has a dedicated person who works with small towns. A professional audit would be undertaken to look at what structure is in place, provide recommendations for development and the support to achieve these. Funding may also be available through the s.106 agreement. • Cllr Coe identified that he was a former Chairman of KBC Planning Committee and a long standing member of the Co-Op. He outlined that the extension of the Tesco Store to the south Kettering has killed the Town. He is concerned that the same will happen in Desborough. He stated that Sainsbury's wheel and deal like many other companies. Mr Nicholson stated that Sainsbury's is a reputable and reasonable company, that he had spoken to the Property Director at the Co-Op last Friday and no approach had been made to them by Tesco with regard to the covenant on the Lawrence Factory Site. Sainsbury's does not feel that the Lawrence Factory Site is a commercially viable scheme even without the covenant in place.

	<ul style="list-style-type: none"> • Cllr Soans asked for further information on Sainsbury’s commitment to the Lawrence Factory Site. Mr Nicholson explained that Hampton Brook is committed to a non-food mixed use development on this site with Sainsbury’s support. At present KBC is not willing to discuss this proposal.
<p>6916</p>	<p>Representations from members of the public</p> <p>Cllr Goodman stated that the members of the public session would be limited to 30 minutes and that each person speaking would be allowed 3 minutes. This was agreed by the Town Council at the meeting held on 16th December 2010 when the up-dated Standing Orders were approved. Cllr Goodman made reference to the practices of other Councils and explained that members of the public play an important part in the Council meeting however it is important to ensure that all Council business outlined on the agenda is given appropriate time for consideration.</p> <p>Members of the public made the following points:</p> <ul style="list-style-type: none"> • A number of Councillors were thanked on behalf of the Army Cadet Force for their donations. • A question was raised as to why Tesco is negotiating with the Oak Tree Pub to buy part of their car park in exchange for doing up the pub. This makes the planning application incorrect. It has been said at a Town Council meeting that Tesco cannot expand the site however this appears to show that they are already expanding. • Sainsbury’s will boost the local community bringing jobs for young people. It is about time the views of local people are taken seriously and not disregarded. • A question was raised as to what has happened to the swimming pool fund. • The Desborough Community Development Trust (DCDT) has opened a shop in the town and they have been inundated with people demanding to sign a petition against the Tesco planning application. The member of the public gestured with his hand behind his back and stated that there seems to be some corruption and this is what people are saying in the town. It was stated that the local MP lied with regard to a question to be debated in the House of Commons. Reference was made to the recent survey undertaken by Cllr Dearing. The member of the public stated that he was proud to be a thorn in the flesh of the Council. • The DCDT recently held a quiz night and nobody from the Town Council had attended. • A question was raised as to the Town Council’s policy on answering questions raised by members of the public under Standing Orders. The member of the public has raised questions at Town Council meetings held in November and December and has not received responses. • A copy of an initial proposal to develop the Lawrence Factory Site into a mixed use development in line with the original brief was given to Councillors. A letter sent from the Developer, Hampton Brook, to Mrs C Bicknell, Head of Planning KBC was read out to the Town Council. The Developer has asked to present the outline plan to KBC, but they have refused. Pressure should be put on KBC to consider other options. • If Hampton Brook is successful in acquiring the Lawrence Factory Site and planning application approval Mr Angus Blair, Managing Director of Hampton Brook, has offered to hand the factory over to DCDT with a sum of £250,000 towards the refurbishment of the factory as long as there is a commitment for a community space and pre-school nursery. • The Hampton Brook proposal includes the provision of factory shops. If Eveden move their factory shop to this site their parking problem would possibly be

resolved.

- Other funding streams will be looked at including the Maud Elkington Charitable Trust.
- A member of the public stated that they were appalled that KBC has sent away the potential developer. Eleven out of twelve of the current Town Councillors supported a mixed use development on the Lawrence Factory Site in their last two manifestos. The Councillors must press KBC hard to make sure the proposed Hampton Brook development becomes a planning application. If the mixed use plan is approved KBC will not have to pay back the funding they received for the Site and the covenant will not have to be removed as it will include only small retail development.
- Concern was raised that the footpath and road alongside the library are in a terrible state due to the current building works taking place. In addition it was suggested that the new building is a waste of money especially as libraries are being closed.

Councillors gave the following responses:

- Cllr Goodman stated that from what she understood Tesco has been in consultation with the Oak Tree Pub in respect of a strip of land which would provide a walkway. As a result the Oak Tree Pub, which is a listed building, may be refurbished. This is not part of the original Tesco Planning Application.
- Cllr Coe stated that he is a Trustee of the Swimming Pool Fund but is not on the Swimming Pool Committee. He gave assurance that the swimming pool money is safe. Over the years various people have requested to use the money for other projects but these requested have been refused. It was **AGREED** that the Town Council will write to the Chairman of the Swimming Pool Committee to ask where the money is.
- Cllr Coe stated that as a Councillor you learn to take knocks however after the Extraordinary Town Council meeting held on 23rd December 2010 Cllr Coe was accused by the Chairman of the DCDT of taking a bribe from Tesco. Cllr Coe felt that this accusation was ‘under the belt’ and he was very hurt by it. He explained that he has been a Councillor for many years and has done his best for the Town regularly walking the town and speaking to people and that he ‘draws the line’ at accusations of this nature.
- Cllr Durward stated that to even suggest Town Councillors take backhanders is a disgrace.
- In respect of the proposed development Cllr Coe stated that this is the type of development the Town Council is looking for however it has been presented very late. If a planning application is submitted to KBC then they will have to deal with it.
- Cllr Dearing stated that it looks a very good scheme and that he is in total agreement with Cllr Coe in respect of this. At present the Lawrence Factory Site land is subject to a ‘Heads of Agreement’ between KBC and Tesco. Cllr Dearing cannot see why this would prevent any other discussions and KBC Planning Department would be obliged to accept any plans genuinely submitted by a developer.
- Cllr Goodman asked Cllr Humfrey, NCC County Councillor, to speak about Desborough library. Cllr Humfrey confirmed that Desborough Library is not one that has been identified for closure. However, members of the public must keep on using the library. Cllr Humfrey is not sure how long the new Sure Start building will take to complete but it will be extremely useful to the community when it is finished.
- Cllr Goodman noted that parking around the library is dangerous adding to problems for pedestrians.

It was RESOLVED to raise a local precept of £17,000 for the following reasons:</p> <ul style="list-style-type: none"> • The substantial reduction in the KBC Grant for 2011/12; • To meet increased on going and additional costs in 2011/12; • Provide adequate support for a new Council and Councillors following the May 2011 Local Elections; • To provide an adjustment increase to General Reserves taking into consideration the payment of £3,800 from General Reserves in 2010/11 for the Parish Poll and the nationally recommended level of reserves that should be held by the Town Council. <p>The following issues were raised and discussed by the Councillors:</p> <ul style="list-style-type: none"> • Cllr Coe stated that he feels that the reduction in the level of grant paid by KBC is pressing the Town Council to precept. The A6 towns and villages pay more than the residents of Kettering. Cllr Coe raised concern about payment for the Parish Poll last year and how this had to be paid for by the Town Council. • Cllr Bindley stated that the Town Council must take into consideration the possibility of someone else calling for a Parish Poll and contingencies need to be made for this. • Cllr Dearing identified that with a precept the Town Council's reserves may need to increase again in the future. If the Town Council does not levy a precept then the new Town Council following the May 2011 elections may have a crisis situation. • Cllr Malin raised concern about the current economic situation for pensioners. A precept is another additional expense combined with all other current cost of living increases. • Cllr Soans highlighted that KBC and NCC are not proposing to increase Council Tax rates for 2011/12 and that Kettering Town ratepayers contribute towards the Town

Demolition of existing buildings on the site.</p> <p>Desborough Town Council supported this planning application by a majority vote at an Extraordinary Town Council meeting held 23rd December 2010. Ten Councillors were present at the meeting. Seven Councillors voted in support of this planning application, three Councillors abstained from voting.</p>																												

<p>6930.2</p>	<p>KET/2010/0744 – Greatline Development Ltd and Tesco Stores Ltd – Former Lawrence Factory Site, Harborough Road, Desborough – Application for Conservation Area Consent: Demolition of existing buildings. Desborough Town Council considered this planning application at an Extraordinary Town Council meeting held on Thursday 23rd December 2010. The following points were noted:</p> <p>The condition of the existing buildings is noted, if the north lights part with its cast iron supports could be incorporated in the new store it might provide an attractive feature linking with its past use. The regeneration of the site with an attractive store bringing 140 full/part time jobs plus 154 car parking spaces (which will support other Town Centre services) is supported. It will begin the much needed regeneration of the whole area.</p> <p>Ten Councillors were present at the meeting. Eight Councillors voted in support of this planning application, two Councillors abstained from voting.</p>
<p>6930.3</p>	<p>KET/2010/0799 – Mr & Mrs Maguire – 39 Ise Vale Avenue, Desborough – Full Application: Single storey rear extension and new pitched roof to existing dining room. No objection. Some drawings state incorrectly Ise Vale Road which should be Avenue.</p>
<p>6930.4</p>	<p>KET/2010/0796 – Mr & Mrs Walters – 9 Furlong Road, Desborough – Full Application: Replacement conservatory. No objection.</p>
<p>6930.5</p>	<p>KET/2010/0819 – Mr Parsons – DTFC, Waterworks Field, Braybrooke Road, Desborough, Kettering – Full Application: Replacement clubhouse. The rebuild is most welcome, re-instating the social fabric and since all of the ground floor will meet DDA needs.</p> <p>There is no doubt that the football club plays (played) a huge social role in/for the Loatlands side of Desborough. However it is extremely disappointing that no effort has been made to alleviate vehicular problems on match days i.e. thought given to better/increased parking areas off road. This is a big minus to this proposed plan.
