## 106./23 ANNUAL WAITING RESTRICTION REVIEW 2023/2024

#### **Extracted from the report of the Town Clerk:**

As Members will be aware North Northamptonshire Council receives a large number of requests to change or introduce parking restrictions across the County. Requests are considered in a programme of annual reviews, initially with local councils and councillors giving their views on locations requiring investigation. A review for the Kettering area has been conducted and NNC is requesting the Town Council's input into the proposals.

Proposal plan(s) for parking restriction changes are set out in Appendix A.

- (a) Cockerel Rise vehicles are parking close to the supermarket and restrictions would allow for a free flow of traffic including buses along this section and keep the immediate area of Ironwood Avenue junction clear;
- (b) Ironwood Avenue to protect the junctions and prevent vehicles parking obstructively
- (c) Rushton Road to protect the junction on to a busy road as vehicles park too close to the junction with Regent Street.

The Council is REQUESTED to give its views on each of the proposed restrictions.

It was stated that each proposal would result in unnecessary displacement, there was no public benefit, and there were no compelling reasons for any of the proposals. RESOLVED that:-

## 107.3./23 TO NOTE THE NORTHAMPTONSHIRE POLICE, FIRE AND CRIME COMMISSIONER PRECEPT CONSULTATION

### **Extracted from the report of the Town Clerk:-**

The Northamptonshire Police, Fire and Crime Commissioner ("the Commissioner") has launched their council tax precept survey for police and fire. The police and fire precepts are the amount that Northamptonshire residents pay towards policing and the fire service through their council tax – together, both precepts amount to around 18% of the council tax a household pays. The Commissioner is recommending an increase in the policing precept of £15 a year for a Band D household, and of £5 a year in the fire precept for 2024/25, which is the amount of funding both services need to sustain both budgets at their current level and meet cost pressures.

Members of the public as well as Councillors are able to complete the online survey which explains the impact that different council tax precept options would have on the policing and fire budgets.
